Special Meeting SOUTH WILLIAMSPORT AREA SCHOOL DISTRICT October 9, 2018

A special meeting of the South Williamsport Area School Board was called to order this evening in the library of the High School at 7:00 p.m. by the President, Chris Branton.

The meeting opened with the moment of silence and Pledge to the Flag.

Chris Branton, Board President began the meeting by going over a sheet that was passed out to the board members and the public. This sheet began with a timeline. The first mention of appeals was at a board meeting on May 7, 2018. There was a newspaper article on May 8, 2019, and the Board approved the appeals process on May 21, 2018. Mr. Branton also went over all of the current tax rates for the school, county and Municipalities. He also went over the Common Level Ratio which is currently .737. He then went over the mean property which is number seventy-eight out of one hundred fifty-six. This property had a purchase price of \$112,500 with an assessment at the time of the sale of \$62,510. The new assessment using the common level ratio is \$82,912, or a change in assessment of \$20,403. This property total increase in taxes would be \$558.43. Some additional facts were that it impacts one hundred fifty-six properties and would provide an additional \$58,000 in revenue. This is not retro-active, the first bill would be in 2019.

Over the next hour and a half, over twenty-five taxpayers, real estate agents and bankers came to the microphone to voice their opposition to this reassessment process the same as they did at the October 1st meeting. Following all of the speakers, Molino made a motion to repeal the appeal process that was approved back in May, seconded by Page. Roll call: Anthony-yes, Bachman-yes, Davenport-yes, Miller-no, Molino-yes, Page-yes, Persun-yes, and Branton-no, motion carried. This means all reassessment scheduled for South Williamsport are cancelled.

Moved by Miller, seconded by Bachman that the meeting be adjourned, all members present voting yes, the meeting was adjourned at 8:50 pm.
